Motion to approve Treasurer's Report by Tietz, second by Steinhoff-Smith. Motion approved.

Motion to Approve to Request by Mission Outreach by Borwege, second by Bishop, motion approved.

• Mission Outreach asks to allocate \$2000 in pastor discretionary funds again for the 2025 year.

Motion to Approve Land Sale Recommendations by Lee, second by Gieseke, motion approved.

- \$20,077 in the Capital Account that was not used and to be forgiven (meaning it can stay in the Capital Account and doesn't need to be reinvested).
- Move \$30,000 from a bond that was called early in 2024 into the Capital Account. Three bonds remain invested (maturities between 2025 and 2030).

Motion to Approve the Designated Gift by Nybo, second by Cornell, motion approved.

• George and Joan Winn have announced in 2025 they will match up to \$150,000 for gifts that are given towards a reserve fund for operations. Action for Pastor Alica and Sharon Steinhoff-Smith to draft an initial communication plan.

Pastor Alicia's Report:

- In 2024, we committed \$25,000 to Mpls Area Synod.
 Motion for our 2025 commitment to the Mpls Area Synod to be \$25,000 by Lee, second by Bishop. Motion approved.
 Action to send the check to Mpls Area Synod ASAP.
- Met with Paul Newton to review our insurance coverage and Paul noted an important change in wind/hail in the deductible that is common now to see in insurance. It is no longer a deductible but a percentage.
 Action - Laura Magnuson to gut check with Langer Construction a value of 7 million building value.
- Motion by Steinhoff-Smith, seconded by Tietz to change the Facility Policy including an exception to not to charge for sacramental events, thus to waive the \$100 fee. Motion approved.

Motion to Approve our Signers Accountant, President, and Treasurer with authority to discuss financial matters with financial institutions (accountant, pastors, president, treasurer) by Lee, second by Tietz, motion approved.

Motion to allow chairs of the endowment team and land sale team to speak to financial institutions by Gieseke and second by Steinhoff-Smith. Motion approved.
